reference, in the sum of Fifteen Thousand and no/100

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Gantt Township, containing 3 acres, more or less, as will appear by reference to plat of Alma McNeil Jones in plat book KK at page 104 and having the following metes and bounds, to-wit:

Beginning at an iron pin at the northeastern intersection of the Air Base Road (Old Augusta Road) and the White Horse Road Extension and running thence along the eastern side of Air Base Road N 0-28 W, 333.2 feet to an iron pin at the corner of property of Alma Jones; thence with her property S 88-42 E, 442.5 feet to an iron pin; thence Due South 96.4 feet to an iron pin; thence a new line approximately Due South 260 feet, more or less, to an iron pin in the northern side of White Horse Road Extn. thence with said road S 87-11 W, 104.5 feet to an iron pin; thence N 86-13 W, 165.5 feet to an iron pin; thence continuing with said road N 86-13 W, 179.9 feet to the point of beginning and being that property conveyed to the mortgagor in deed book 521 at page 173, deed book 618 at page 334 and deed yet to be recorded of even date herewith by William Bryan Jones.
