(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Citizens Lumber Company

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of One Thousand and No/100

DOLLARS (\$ 1000.00),

with interest thereon from date at the rate of Six per centum per annum, said principal and interest to be repaid: sixty days after date, with interest thereon from date at the rate of six per cent, per annum, to be computed semi-annually and paid monthly

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

at the northwestern corner of Drury Lane and Bonair Street, being shown as lot # 48, on the plat of Glendale recorded in Plat Book KK at Page 129, and described as follows:

BEGINNING at a stake at the northwestern corner of Drury Lane and Bonair Street, and running thence with the Western side of Bonair Street, N. 11-16 E. 130 feet to a stake at corner of lot 79; thence with the line of said lot N. 78-44 W. 135 feet to a stake at corner of lot 49; thence with the line of said lot, S. 11-16 W. 155 feet to a stake on Drury Lane; thence with the northern side of said Lane S. 78-44 E. 110 feet to a stake at the corner of Bonair Street; thence with the curve of the intersection, the chord of which is N. 56-16 E. 35.3 feet to the point of beginning.

It is understood that this mortgage is junior in lien to a mortgage held by Citizens Lumber Company in the original sum of \$5900.00, and also to a mortgage held by William R. Timmons, Jr.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
