And if at any time any portion of principal or interest shall be past due and unpaid, or if default be made in respect to any condition, agreement or covenant contained herein, then the whole sum of the principal of said note remaining at that time unpaid together with the accrued interest, shall become immediately due and payable, at the option of the holder thereof, who may sue thereon and foreclose this mortgage; and if said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if, before its maturity, it should be deemed by the holder thereof necessary for the protection of its interests to place, and the holder should place, the said note and mortgage in the hands of an attorney for any legal proceedings; then and in either of such cases the mortgager promises to pay all costs and expenses including a reasonable attorney's fee, these to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that lot of land with the improvements thereon situate, lying and being on the Northwest side of West Prentiss Avenue in the City of Greenville, Greenville County, South Carolina, being shown as Lot No. 4, Block "F" on Plat of property of O. P. Mills made by H. O. Jones, Engineer, May 1914, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "C" pages 175 and 176 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwest side of West Prentiss Avenue at joint corner of Lots 2 and 4 of Block F, said pin being 65 feet in a westerly direction from the Northwest corner of the intersection of West Prentiss Avenue and Ladson Street and running thence with the line of Lot 2, N. 44-33 W. 180 feet to an iron pin; thence S. 45-27 W. 65 feet to an iron pin in line of Lot No. 6; thence along the line of Lot 6, S. 44-33 E. 180 feet to an iron pin on the Northwest side of Prentiss Avenue; thence with West Prentiss Avenue N. 45-27 E. 65 feet to the beginning corner.
