All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Fairview Township being known and designated as a part of 30.9 acres of property in accordance with Plat made for W. T. Jones by W. J. Riddle, dated August 1, 1945 and being more fully described in accordance with said Plat, to-wit:
