NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the West side of Belmont Avenue, in the City of Greenville, and having according to a survey made by C.M. Furman, Jr., dated February 23, 1928, the following metes and bounds, to wit:

BEGINNING at an iron pin on the west side of Belmont Avenue, which pin is 170.5 teet south of the southwest corner of Belmont Avenue and Cleveland Street, and which pin is also the southwest corner of Belmont Avenue and a 10-foot alley, and running thence along the west side of Belmont Avenue, S. 4-11 W., 74 feet to an iron pin; thence N. 34-50 W., 150 feet to an iron pin; thence N. 4-11 E., 74 feet to an iron pin on the south side of a 10-foot alley; thence along the south side of said alley, S. 34-50 E., 150 feet to the point of beginning.
