"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Grove Township, about two (2) miles North of Piedmont on West side of Highway # 29 at rear of J. W. Brock being a portion of the original plat of J. W. Brock as made by W. F. Adkins, Surveyor, March 3, 1936, and described as follows: BEGINNING at an iron pin as the lower left hand corner on a point of the property now being conveyed and B. D. Cothran running thence North 31-10 East 231 feet to a pin and to the center of road leading to the pin of J. R. Shirley, thence along said road and along the center of the road in a Westerly direction for 175 feet to an iron pin in center of road, thence Southwest 129 feet along the line of J. W.
