"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the western side of Duke Street, near the City of Greenville, being shown as Lot 25 of Sec. 3, on a plat of Dunean Mills recorded in Plat Book S, Page 175, and described as follows:

BEGINNING at a stake on the western side of Duke Street 242.5 feet south from Kelly Street and running thence N. 64-16 W. 153.3 feet to a stake on an alley; thence with said alley S. 25-22 W. 80 feet to a stake; thence S. 64-16 E. 152.6 feet to a stake on Duke Street; thence with the western side of said street N. 25-44 E. 80 feet to the beginning cofner.
