(hereinafter referred to as Mortgagor) SEND(S) GREETING.

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

Fifteen Hundred and No/100 DOLLARS (\$1500.00), with interest thereon from date at the rate of Six (6%)

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Greenville Township, being known and designated as lot # 9, as shown on plat of East Augusta Place recorded in Plat Book F at Page 128, and being more particularly described as follows:

BEGINNING at an iron pin joint front corner of lots # 8 and 9, and running thence N. 26-30 W. 249.8 feet to an iron pin, joint rear corner of lots # 8 and 9; thence N. 63-30 E. 60 feet to an iron pin, joint rear corner of lots # 9 and 10; thence S. 26-30 E. 244.4 feet to an iron pin in Augusta Place, joint front corner of lots # 9 and 10; thence with Augusta Place, S. 58-30 W. 60.23 feet to the beginning corner.

Said premises being the same conveyed to the mortgagors herein by Mrs. R. K. Howell by deed recorded in Book 288 at Page 289.
