(hereinafter referred to as Mortgagor); SEND(S) GREETING

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of
 ----- Twenty-Eight Thousand and No/100 -----

DOLLARS \$ 28,000.00) with interest thereon from date at the rate of Five & Three-Fourths per centum per annum, said principal and interest to be repaid in monthly instalments of One Hundred Seventy Seven and No/100 ----- Dollars (\$177.00) each on the first day of each month hereafter until the principal and interest are fully paid, each payment to be applied first to payment of interest and then to payment of principal, and

WHEREAS the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, including advances made by the Mortgagee on other or no security

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, being known and designated as Lot No. 20 on plat of property of Knollwood Subdivision, Sunset Drive, recorded in Plat Book EE at Page 35, in the R.M.C. Office for Greenville County, and having according to said plat the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the northern side of Sunset Drive, joint front corner of Lots 20 and 21, and running thence with line of Lot 21, N. 25-29 E. 175 feet to iron pin; thence S. 64-31 E. 90 feet to iron pin, joint rear corner of Lots 19 and 20; thence with line of Lot 19, S. 25-29 W. 175 feet to iron pin on Sunset Drive; thence with said Sunset Drive N. 64-31 W. 90 feet to the point of beginning. Being the same property conveyed to the mortgagor by J. Alvin Gilreath by deed of even date, to be recorded herewith."

ALSO:

"All that lot of land in Greenville County, State of South Carolina, on the eastern side of South Warwick Road, in Paris Mountain Township, near the City of Greenville, being known and designated as Lot No. 78 of a subdivision known as Stratford Forest, and shown on a plat of said subdivision prepared by Piedmont Engineering Service, dated February 25, 1957, recorded in Plat Book KK at Page 89. (Reference to said plat being made for a further metes and bounds description). Being the same property conveyed to the mortgagor by DuPre Rhame by deed to be recorded herewith."

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
