All that piece pareel or lot of land, with all improvements thereon, or hereafter constructed thereon, sturate lying and being on the Morthern side of Bramlett Road near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 58 as shown on a plat of Morgan Hill Addition, dated May 15, 1902, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book A at page 69, and having according to said plat the following metes and bounds:
