NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, **Paris Mountain Township** at the **Southeast** intersection of **Old Buncombe Road** and **New Perry Road** and according to a survey and plat by **J. M. Prevatte** dated **May, 1961** for **Sloan E. Goldsmith** has the following metes and bounds.

BEGINNING at an iron pin at the Southeastern intersection of Old Buncombe Road and New Perry Road and running thence along the South side of New Perry Road, N. 84-17 E. 200 feet to an iron pin; thence S. 5-49 E. 129 feet to an iron pin in line of Robert L. Goldsmith; thence N. 87-40 W. 209.1 feet along line of Roberts L. Goldsmith to an iron pin on the Eastern side of Old Buncombe Road; thence N. 0-44 W. 117 feet along the Eastern side of Old Buncombe Road to point of beginning.
