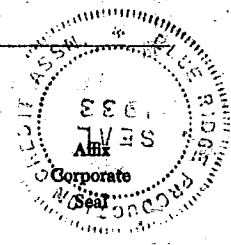
For and in consideration of the sum of One Dollar (\$1.00), and other good and valuable consideration, to it in hand paid at or before the signing, sealing and delivery of these presents, receipt of which is hereby acknowledged, BLUE RIDGE PRODUCTION CREDIT ASSOCIATION, a corporation, the owner and holder of a certain mortgage, executed by Lawrence L. Hyder, Leila J. Hyder, Joe Hyder & Jean C. Hyder to it, on September 30, 1960, recorded in Mortgage Book 838, page 357 and renewal mortgage dated May 21, 1962, recorded in Mortgage Book 891, Page 267. of Greenville County, South Carolina, does hereby release and relinquish the lien of said mortgage

insofar, and so far only, as the same covers and embraces the following described property: All that tract of land located in Glassy Mountain Township, Greenville County, S. C., containing 119 acres, more or less, according to plat made by J. E. Atkins in March, 1934, and being the same lands as shown on that plat as Tracts Nos. 6; 7; 8; 9; 10; and 11 and being bounded by lands now or formerly of Willis Bruce lands, Taylor-Colquitt Co. on the North; on the East by Willis Bruce lands and the Estate of General Pierce; on the South, by Tract No. 4 on the Atkins plat and on the West by Norris, Wade Plumley lands, Tract No. 12 as shown on the Atkins plat, together with the Taylor-Colquitt Co. Reference is here made to the Atkins plat which is recorded in Book H, Page 239, Greenville County for a definite and particular description of the said lands. This is the identical property conveyed to Leila Hyder and Joe Hyder from Henry J. Pritchard, said deed recorded in Deed Book 323, Page 245; said deed conveying 102.75 acres. And the identical property conveyed to Leila Hyder from R. L. Lockhart, said deed conveying Lot No. 6 on said plat and being dated May 24, 1948, recorded in Deed Book 349, Page 107, Greenville County, South Carolina. the said mortgage to remain in full force and effect, and in all other respects unchanged as to the rights given therein to the holder of said mortgage.
