NOW, KNOW ALL, MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and furthersums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his accont by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in or near Piedmont, being Lots 10 and 11 on plat by F. E. Ragsdale, April and August, 1962; fronting on Oak Hill Drive.

The foregoing lots were conveyed to mortgagor by deed of James S. Cooley, August 27, 1962, recorded in the R. M. C. Office for said County in Deed Book 707 at page 53.

The above described lots are a portion of "Whispering Pines Subdivision-North of Piedmont, S. C., and having the following courses and distances: fronting on Oak Hill Drive and beginning at a point on said street and running thence North 17-18 West for 217.2 feet to pin on Woodlawn Drive, thence South 61-30 East for 259.8 feet to pin, thence North 30 East for 154.4 feet to pin on Oak Hill Drive, thence 100 feet to the beginning.
