The note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder, become immediately due and payable, and the holder may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses, of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That I/we, the said mortgagor (a) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt wheeled is hereby acknowledged); have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, being known and designated as Lot #54 as shown on a plat of Oakwood Acres, Section 2, prepared by Piedmont Engineering Service, dated May 1962, recorded in the R. M. C. Office for Greenville County in Plat Book AAA, Page 38, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the eastern side of East Lee Road, joint corner of Lots Nos. 1 and 54, and running thence along the curvature of the intersection of East Lee Road with Strange Road, the chord being S. 5-03 E. 46.8 feet to an iron pin on the northeastern side of Strange Road; thence along the northeastern side of Strange Road, S. 25-36 E. 124.0 feet to an iron pin; thence following the curvature of Strange Road as it intersects with an unnamed street, the chord being S. 51-02 E. 40.8 feet, to an iron pin on the northern side of said unnamed street; thence along the northern side of said unnamed street; N. 83-37 E. 127.3 feet to an iron pin at the corner of Lot No. 53; thence along the line of that lot, N. 5-38 W. 145.0 feet to an iron pin on the line of Lot No. 52; thence along the line of that 40t, N. 82-30 W. 28.7 feet to an iron pin on the rear line of Lot No. 1; thence along the rear line of Lot No. 1, S. 15-30 W. 34.0 feet to an iron pin; thence along the joint line of Lots Nos. 1 and 54, N. 74-0 W. 175.0 feet to the beginning corner; being the same conveyed to me by Ruby S. Jeffers by deed of even date, to be recorded herewith."

In addition to the above mentioned monthly payments of principal and interest payable under the terms of the note secured hereby, the mortgager (s) agree (s) to pay to the mortgagee on the first day of each month until the note secured by this instrument is fully paid, the following sums:
