All that certain piece parcel or tract of land situate, lying and being on the North side of the Spartanburg-Greenville Super Highway near the Town of Taylors in Chick Springs Township, Greenville County, South Garolina, containing 2.5 acres according to plat made by G.W. Ellis, Surveyor, August 21, 1947 and having according to said plat the following metes and bounds, to wit:

BEGINNING on the Northwest side of the Spartanburg-Greenville Super Highway at corner of property now or formerly of Ruth Hudson and running thence with said Hudson line, N. 68k W. 149 feet to an iron pin and still with said Hudson line, N. 4k E. 118 feet to an iron pin; thence with line of property of H.R. Stephenson N. 77 3/4 E. 491 feet to an iron pin on the Northwest side of the Super Highway; thence along the Northwest side of said Highway, S. 52k W. 434. Feet to the beginning corner.
