That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagor at any time for advances made to or for his account by the Mortgage, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina. County of Greenville, Chick Springs Township, on the north side of Confederate Avenue between Taylors and Greenville, and being Lot No. 12 of SHEFFIELD FOREST according to survey and plat by Carolina Engineering and Surveying Company, dated February 21, 1962, recorded in Plat Book AAA, page 47, R.M.C. Office for Greenville County, and having the following courses and distances, to-wit:

BEGINNING at an iron pin on the north side of Confederate Avenue, corner of Lots Nos.11 and 12, and running thence along said Avenue, S. 84-00 W. 100 feet to an iron pin, corner of Lot No. 13; thence along line of Lot No. 13, N. 6-00 W. 150 feet to an iron pin on the rear line of Lot No. 4; thence along the line of Lots Nos. 4 and 5, N. 84-00 E. 100 feet to the corner of Lot No. 11; thence along the line of Lot No. 11, S. 6-00 E. 150 feet to the beginning corner. corner.
