ALL that lot of land, with the buildings and improvements thereon, situate on the Bast side of Edwards Road, near the City of Greenville, in Greenville County, S. C., being shown as Lot No. 5, Section 1, on plat of Orchard Acres, made by Piedmont Engineering Service, October 21, 1953, recorded in the R. M. C. Office for Greenville County, S.
