WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Thirty-Five Thousand and No/100 - - - - - (\$35,000,00) Dollars (or for future advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes se-

cured hereby), said note to be repaid with interest at the rate specified therein in installments of

Two Hundred Twenty and 20/100 - - - - - (\$ 220.20 ) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest, has been paid, such monthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal balances, and then to the payment of principal. The last payment on said note, if not paid earlier and if not subsequently

extended, will be due and payable \_\_\_\_\_25\_\_ years after date. NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, seconding to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

Office for Greenville County in Plat Book QQ, at Page 78, and according to said plat is described as follows:

"BEGINNING at an iron pin on the southern side of Normandy Road, at the joint corner of Lot 26 and running thence with the line of said lot, S. 6-01 W. 225 feet to an iron pin; thence N. 86-18 W. 140. 8 feet to an iron pin at the rear corner of Lot 28; thence with the line of said lot, N. 1-14 E. 225 feet to an iron pin on the southern side of Normandy Road; thence with the southern side of said road, S. 86-57 E. 102.7 feet to a point; thence continuing with said road, S. 85-07.
