NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northeastern side of Scuffletown Road, and having according to plat of the property of L. A. Fowler, made by W. J. Riddle, March 1927, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the northeastern side of Scuffletown Road, and running thence N. 52-15 W. 939 feet to point; thence continuing with said Road N. 46-45 W. 944 feet to iron pin; thence N. 62-25 E. 1345 feet to iron pin; thence S. 37-45 E. 690 feet to iron pin on branch; thence S. 86-30 E. 772 feet to iron pin; thence S. 30-20 W. 1275 feet to iron pin; thence S. 67 W. 446 feet to iron pin, the point of beginning, containing 50 acres, more or less."
