NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgage at any time for advances made to or for his account by the Mortgage, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the Southeasterly side of Dogwood Lane, and being known and designated as

Lot No. 182 and the Westerly adjoining one-half of Lot No. 183, as shown on Plat of Cleveland Forest, prepared by Dalton & Neves, Engineers, in May, 1940 (revised in October, 1950), which Plat is recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book M, at pages 56 and 57, and having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southeasterly side of Dogwood Lane, common corner of Lots Nos. 181 and 182; said pin being located 150.9 feet Northeast of an iron pin on the Southeastern side of Dogwood Lane; thence along the rear lines of Lots Nos. 179, 180 and 181, S. 57-55 E. 150 feet to an iron pin at rear corner of Lots Nos. 178, 179 and 182; thence N. 52-33 E. 80 feet to an iron pin at the center point on the rear line of Lot No. 183; thence through the center of Lot No. 183, N. 49-53 W. 195.5 feet to an iron pin at the center point in the front line of Lot No. 183 on the Southeasterly side of Dogwood Lane; thence along said Lane on an angle (the chord of which is S. 30-13 W.) 34.5 feet to an iron pin, at joint front corner of Lots Nos. 182 and 183; thence continuing along Dogwood Lane on an angle (the chord of which is S. 18-56 W.) 69.5 feet to point of beginning.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household fugniture, be considered a part of the real estate.
