BEGINNING on a large stone on the north east corner of the lot running thence S 60-45 W. 200 feet to an iron pin; thence N. 46-15 W. 179 feet to a pin in the road; thence with the road as the line N. 53-15 E. 200 feet to a bend in the road; thence S. 82-30 E. 139 feet to a bend on the old line of D.
