NOW, KNOW ALE MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate lying and being near Wing's Landing on the Saluda River in Paris Mountain Township, Greenville County, State of South Carolina, and having according to a plat of Property of C.M. Wing, dated May, 1938, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book J at page 27, the following metes and bounds:

BEGINNING at an iron pin in a creek at the corner of property now or formerly of C.M. Wing and property now or formerly of W.B. Farr, and running thence with the line of the said Farr property N. 80-45 E. 570 feet to an iron pin at the corner of property now or formerly of C.M. Wing; thence with the line of the said Wing property S. 9-15 E. 100 feet to an iron pin; thence continuing with the line of the said Wing property S. 80-45 W. 570 feet to an iron pin in a creek; thence up said creek N. 9-15 W. 100 feet to the point of beginning.

ALSO:

All the right, title and interest of the mortgagor herein in and to the use of a 16 foot right of way along the Northern boundary of the property of C.M. Wing as shown on the plat referred to hereinabove adjoining property now or formerly of W.B. Farr, and running from the premises hereinabove described to a county road approximately 350 feet East of said premises.
