"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville. All that piece, parcel or lot of land situated, lying and being on the Northeastern side of the Augusta Road (Highway No. 25), being shown on a plat prepared by C. C.Jones, Engineer, dated February 8, 1955, entitled "Property of Sarah E. Stoddard Neely Near Greenville, S. C." recorded in the RF.M.C. Office for Greenville County in Plat Book II at page 51, and having according to said plat the following metes and bounds, to wit:

BEGINNING at a point on the Augusta Road (Highway 25) and running thence N. 59-30 E. 7 feet to an iron pin; thence N. 59-30 E. 843 feet to an iron pin; thence S. 30-30 E. 280 feet to an iron pin; thence S. 59-50 W. 789.4 feet to an iron pin; thence S. 59-50 W. 23.1 feet to a point on the Augusta Road; thence N. 38.20 W. 276.9 feet to the point of beginning.

Together with all and singular rights, members, herditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had thereform, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is sawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
