a corporation chartered under the laws of the State of South Carolina, is well and truly indebted

to the mortgagee in the full and just sum of Ninety-Four Hundred and No/100 (\$9,400.00) - -

Dollars, in and by its certain promissory note in writing, of even date herewith, due and payable on or before six (6) months from date hereof, and upon demand thereafter,

with interest from the date hereof at the rate of Five and One-Half (5½%)
percentum until paid; interest to be computed and paid Semi-Annually

until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of its interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses, including ten per cent of the indebtedness as attorney's fee, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

BEGINNING at an iron pin on the eastern side of said Road, joint front corner of Lots 158 and 159 and running thence S. 64-08 E. 107.3 feet along the joint line of said lots to an iron pin, joint rear corner of said lots and Lots 146 and 147; thence S. 17-28 W. 80.5 feet along the joint line of Lots 147 and 158 to an iron pin, joint corner of said lots and Lots 148 and 157; thence N. 64-17 W. 116.1 feet along the joint line of Lots 157 and 158 to an iron pin on the eastern side of said Road, joint front corner of said lots; thence N. 23-46 E. 80 feet along the eastern side of said Road to an iron pin, the point of beginning.
