OLA S. BURGER SEND GREETING:

Whereas, I, the said Ola S. Burger
in and by my certain promissory note in writing, of even date with these
Presents, am well and truly indebted to J.C. Roper, d.b.a., Southern Motor Finance Company
in the full and just sum of Eight Hundred Seventy-One and 25/100
dollars, to be paid \$72.75 per month until paid in full beginning
May 12, 1963,

with interest thereon from maturity
at the rate of 7 per centum per annum, to be computed and paid semi-annually
until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid,
the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who
may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the
hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof
necessary for the protection of his interests to place and the holder should place the said note or this mortgage
in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises
to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to
the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

gained, sold and released, and by these Presents do grant, bargain, sell and release unto the said
J. C. Roper, dba, Southern Motor Finance Company, his heirs and assigns; forever;

1. ALL that piece, parcel or lot of land, with the improvements thereon situate,
lying and being in or near the City of Greenville County, South Carolina, and
being more particularly described as Lot 57, Section B, as shown on a plat entitled
"A Subdivision for Woodside Mills, Greenville, S.C." made by Pickall & Pickell,
Engineers, Greenville, S. C., January 14, 1950, as recorded in the R.M.C. Office
for Greenville County in Plat Book W., at Pages 11 & 17, inclusive, according to
said plat the within described lot is also known as No. 53 West Sixth Street
(Avenue) and fronts thereon 103.9 feet.

The above property conveyed is subject to all restrictions and easements as set
forth in the Original Deed and Plat of the Woodside Mills, of which reference is
hereby made,
