"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the Green Mill Village in the City of Green, and being more particularly described as Lot No. 17 as shown on a plat entitled "Subdivision of Green Mill Village, Green, S.C." made by Dalton & Neves, January, 1951, and recorded in the R.M.C. Office for Greenville County in Plat Book "Y", pages 138 and 139. According to said plat the within described lot is also known as No. 37 Hollis Street and fronts thereon 60 feet.
