DOLLARS (\$ **9,000.00**), with interest thereon from date at the rate of **six (6%)** per centum per annum, said principal and interest to be paid as therein stated, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of **Greenville**, in **Chick Springs Township**, shown as **Lot 51 on plat of Clearview Acres**, recorded in plat book **MM** at page **168**, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the northern side of Clearview Circle, at the joint front corner of Lots 51 and 52, and running thence along the line of Lot 52, N 3-15 E, 175.0 feet to an iron pin; thence N 86-45 W, 100 feet to an iron pin; thence along the line of Lot 50, S 3-15 W, 175.0 feet to an iron pin on the northern side of Clearview Circle; thence along said Circle, S 86-45 E, 100 feet to the point of beginning and being the same property conveyed to me by deed of George H.
