VILLE, in the full and just sum of Thirteen Thousand. Two Hundred Fifty and /. (\$.13,250.00.) Dollars (or for tuture advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes se-

cured hereby), said note to be repaid with interest at the rate specified therein in installments of....

Eighty-Five and 38/100 - - - - - - - (\$ 85.38) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest, has been paid, such monthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal balances, and then to the payment of principal. The last payment on said note, if not paid earlier and if not subsequently

extended, will be due and payable 25 years after date. C. Jones, C. E., dated November 1962, and recorded in the R.M.C. Office for Greenville County in Plat Book XX at Page 97, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the southern side of Charing Gross Road, joint front corner of Lots 13 and 14 and running thence along the joint line of said lots, S. 11-27 W. 151 feet to an iron pin on the rear line of Lot 15; thence along the line of that lot, S. 80-35 E. 80 feet to an iron pin at the joint rear corner of Lots 15 and 11; thence along the line of Lot 11, S. 78+30 E. 10 feet to an iron pin at the joint rear corner of Lots 13 and 12; thence along the line of a lot heretofore conveyed by Mauldin Construction Co. to J. Calvin Peace, III, N. 29-06 E. 143.7 feet to an iron pin on the southern side of Charing Cross Road; thence along the southern side of Charing Cross Road, N. 58-48 W. 30 feet to an iron pin at the joint front corner of Lots 12 and 13; thence continuing along the southern side of Charing Cross Road, N. 72-45 W. 48.2 feet to an iron pin; thence continuing along the southern side of Charing Cross Road, N. 81-15 W. 62.2 feet to the beginning corner; being the same conveyed to us by Mauldin Construction Co. by deed of even date to be recorded herewith."
