And the said mortgagor & agree to insure and keep insured the houses and buildings on said lot in a sum not less than Nineteen Thousand Five Hundred and No/1600 hars in a company or companies satisfactory to the mortgagee from loss or damage by fire, and the sum of Nineteen Thousand Five
