C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, lying on the North side of the road that leads from the Reid School Road to Highway No. 415 by way of Pleasant View Baptist Church, being bounded now or formerly on the East by Claude W. Dill, on the South by said road and lands of W. Hubert Bridwell, on the West by lands of James R. Turner and Mary Ann Turner, and on the North by lands of W. Hubert Bridwell, and being the same property conveyed to Nettie T. Turner by Robert Lee Turner et al by deed recorded in deed book 697 page 407, Greenville County R. M. C. Office and having the following metes and bounds, to wit:

Beginning on a nail in the center of the said road and on the Claude W.
