McAbee , in consideration of the said debt and sums of money aforesaid, and for the better securing the payment thereof to the said Ctylens Building and Loan Association, Greer, S. C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to us the said mortgagor. In hand well and truly paid by the said mortgage, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and released unto the said Ctylens Building and LOAN ASSOCIATION, Green, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, O'Neal Township, about four miles northwest of Greer. lying on the south and east side of LAKE C'MNINGHAM and being a part of the same tract of land conveyed to William McAbee by deed from Joel T. Roe February 23rd 1944, recorded in the office of the R. M. C. for Greenville County in Deed Book 261 at page 112, and having the following courses and distances, to wit: -

S. 2-30 E. 37 feet from an old stone and iron pin corner by a large Poplar stump, the said iron pin being on the 850 elevation line of the water right of the City of Greer, S. C., and runs thence with the Lee Styles line S. 2-30 E. 219 feet to a stake in a new cut road (North Lake Road) (1ron pin back on line at 24 feet); thence with the center of the said road, S. 82-27 W. 294 feet to a nail and cap; thence S. 78-07 W. 100 feet to a nail and cap; thence S. 65-07 W. 100 feet to a nail and cap; thence S. 35-46 W. 90 feet to a mail and cap in the center of the said road; thence N. 75-04 W. 20 feet to an iron pin on the northwest margin of the road, then continuing with the same course for a total distance of 192.5 feet to an iron oin on the said was on elevation water right line of the City of Greer; thence with the 850/water right line with the following courses and distances: N. 23-20 W. 85 feet to an iron pin; thence N. 28-00 E, 120.7 feet to an iron pin; thence N. 57-53 E. 186.8 feet to an iron pin; thence N. 86-15 E. 312.3 feet to an iron pin; thence N. 84-01 E. 156.3 feet to an iron pin; thence N. 64-02 E. 123.4 feet to the beginning corper. containing Three and Fifty Seven One-hundredths (3.57) Acres, more or less.
