C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of ---Twenty Thousand Three Hundred and No/100---

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the southern side of East Washington Street, in the City of Greenville, having the following metes and bounds, to-wit:

BEGINNING at an iron pin at the corner of David Kohn's lot, and running thence S. 27-13 E. 219.5 feet to a stake on C & W C Railroad right-of-way; thence with said right-of-way, N. 49-43 E. 60 feet to stake; thence in a line parallel with Kohn's line to stake on Washington Street; thence S. 69-15 W. 60 feet along Washington Street, to the beginning corner.
