"All that certain piece, percelor lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Western side of the turn-around at the intersection of Monaghan Avenue and Louise Avenue and shown as lot No. 35 on a plat entitled Map of Victor-Monaghan Co., Development No. 1, 120-3 corded in the R.M.C. Office for GreenvilleCounty in Plat Book M at Page 39, and having according to said plat, the following metes and bounds, to-wit:

EXGINNING an iron pin on the Western side of the turn-around at the intersection of Monaghan Avenue and Louise Avenue at the corner of lot No. 36; thence with line of said lob, N. 82-53 W. 137.4 feet to anciron pin; thence N. 13-58 E. 160 feet to an iron pin; at the corner of lot No. 34; thence with line of said lot, S. 69-37 E. 202.3 feet to a point on the Western side of the turn-around at the intersection of Monaghan Avenue and Louise Avenue; thence along the Western side of said turn-around, B. 57-0 W. 70 feet to an iron pin; thence S. 28-16 W. 65 feet to the point of beginning.
