"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of ~~Bokeley~~ Greenville, on the northeastern side of Brownwood Drive, being shown and designated as Lot #140 on plat of Oak Crest, recorded in the R.M.C. Office for Greenville County in Plat Book GG at pages 130 and 131, and having according to said plat, the following metes and bounds, to-wit: BEGINNING at an iron pin on the northeastern side of Brownwood Drive, at the joint front corner of Lots #140 and 141, and running thence with the line of Lot #141 N. 29-12 E. 150 feet to an iron pin; thence N. 60-48 W. 70 feet to an iron pin at the corner of Lot #139; thence with the line of Lot #139 S. 29-12 W. 150 feet to an iron pin on Brownwood Drive; thence with the northeastern side of said Drive S. 60-48 E. 70 feet to the point of BEGINNING; being the identical property conveyed to Jack P.
