(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand-well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville, on the northern side of Wembley Road, shown as Lot No. 266 on Plat of Gower Estates, Section B; as shown on plat recorded in Plat Book XX at Pages 36 and 37 in the R.M.C. Office for Greenville County, and according to said plat described as follows:

BEGINNING at an iron pin on the northern side of Wembley Road, at the corner of Lots Nos. 267 and 266 and running thence along the line of Lot 267, N. 51-39 W. 171.6 feet to iron pin, corner of Lots 249 and 250; thence along the line of Lot 250, S. 46-58 W. 118 feet to an iron pin, corner of Lots 251 and 259; thence along the line of Lot 259, S. 15-56 W. 76.8 feet to iron pin, corner of Lot 265; thence along line of Lot 265, S. 75-14 E. 156.6 feet to iron pin on the northern side of Wembley Road; thence along Wembley Road N. 27-57 E. 190 feet to the point of beginning.
