NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better againing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"BEGINNING at an iron pin on the west side of Burgundy Drive at the joint front corner of Lots 15 and 16, and running thence with the line of Lot No. 16, S. 76-20 W. 200 feet to an iron pin) thence N. 13-40 W. 95 feet to an iron pin, joint rear corner of Lots 14 and 15; thence with the line of Lot No. 14, N. 76-20 E. 199 feet to an iron pin on Burgundy Drive; thence with said Burgundy Drive, S. 15-07 E. 36.7 feet to an iron pin; thence continuing with said Drive, S. 13-40 E. 58.4 feet to the beginning corner; being the same conveyed to me by Doris Pellizzi by deed of even date to be recorded herewith.
