NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina: in the City of Greenville, S. C. on the southern side of East Tallulah Drive and being known and designated as Lot No. 25 on plat of property of Estate of D. T. Smith recorded in the R. M. C. Office for Greenville County in Plat Book "H", at Page 279 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of East Tallulah Drive at the joint front corner of Lots Nos. 23 and 25 and running thence along said Drive N. 64-40 E. 100 feet to an iron pin; thence along the line of Lot No. 29 S. 25-20 E. 200 feet to an iron pin; thence S. 64-40 W. 100 feet to an iron pin; thence along the line of Lot No. 23 N. 25-20 W. 200 feet to the point of beginning.
