"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, known and designated as Lot No. 4 property of R. J. Sentell, recorded in the R. M. C. Office for Greenville County in Plat Book "I", at Page 75, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern side of the Easley Highway, joint front corner of Lots No. 4 and 5 and running thence N. 16-53 E. 223 feet to an igon pin, rear corfler of Lot No. 4; thence along the rear line of Lot No. 4, N. 51-31 E. 67.8 feet to an iron pin, joint rear corner of Lots No. 3 and 4; thence along the common line of Lot No. 3, S. 28-35 E. 224 feet to an iron pin on the northwestern side of the Easley Highway; thence along the said Highway, 8. 58-45 W. 112.8 feet to an iron pin, the point of beginning.
