All that piece, parcel or lot of land, with all improvements thereom or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the south eastern side of a circular turn-around at the northern end of Birch Court, and shown as Lot 14 on a plat of Beechwood Hills recorded in the d.H.C. Office for Greenville County in Plat Book "QQ", at Page 35, and naving according to said plat the following metes and bounds:

BEGINNING at an iron pin on the southeastern side of Birch Court at the joint corner of Lot 15 and running thence with the line of said Lot 15 5.50-05 E. 295.7 feet, crossing an iron pin to the center of a branch; thence with said branch as the line, the traverse of which is N. 47-22 E. 101.4 feet to an iron pin in said Branch; thence N. 30-04 W. 339.1 feet to the corner of Lot 13; thence with the line of said lot S. 39-55 W. 122.9 feet to a point on the circular turn-around above described; thence with the side of said turn-around of Birch Court, the chords of which are S. 5-05 E. 70.7 feet and S. 69-55 W. 50 feet to an iron pin at the point of beginning.
