considerations, the receipt of which is hereby acknowledged, said Twinside Company, Inc.
party of the first part, has bargained, assigned, transferred and sold and
by these presents doth bargain, assign, transfer and convey without recourse unto the
said Hamla Corporation of North Carolina, Inc. party of the second part, its heirs, executors, ad-
ministrators, and assigns that certain mortgage deed of trust bearing date of the
11th day of July, 1963, made by and between Twinside
Company, Inc., ~~Trustee~~ and Howell A. Hammett & Dorothy L. Hammett
all of the State of North Carolina, to secure payment of \$ 4,302.60, payable in 60
months from the date thereof, with interest payable \$ 71.71 monthly at the rate
of 6 per cent per annum, which said mortgage deed of trust is recorded in Book 929
Page 407 in the Office of the Clerk of Court
Register of Deeds for Greenville
County and together with the note thereby secured and the money due and to become due
thereon and also together with all right, title and interest of the party of the first
