TO ALL WHOM THESE PRESENTS MAY CONCERN: We, John O. Vernon, Jr.

and Zelle B. Vernon, (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C. (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Eighteen Hundred and Fifteen -----

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in or near

Travelers Rest, and being more particularly described as Lot No. 7

as shown on plat entitled "Subdivision for Abney Hills, Renfrew

Plant, Travelers Rest, South Carolina," made by Dalton & Neves,

Engineers, Greenville, S. C., January, 1959, and recorded in the Office

of the R. M. C. for Greenville County in Plat Book No. 96, page 53.

According to said plat the within described lot is also known as

No. 6 Park Avenue, and fronts thereon 123.8 feet.
