"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, being known and designated as

Lot No. 17-C of the property of Maggie Mae Buff Lampe recorded in the R. M. C. Office for Greenville County in Plat Book "R", at Page 151, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Loom Street (formerly known as Mill Street), joint front corner of Lots No. 17-C and 17-D and running thence along the line of Lot No. 17-C, N. 21-30 E. 95 feet to an iron pin; thence along the rear line of Lot No. 17-C, N. 68-30 W. 50 feet to an iron pin, joint rear corner of Lots No. 16 and 17-C; thence along the line of Lot No. 17-C, S. 21-30 W. 95 feet to an iron pin on the northern side of Loom Street (formerly known as Mill Street), thence along said street S. 68-30 E. 50 feet to an iron pin, the point of beginning.
