ROBERT HUNT (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Three Thousand, Eight Hundred and No/100ths-----**
DOLLARS (\$3,800.00), with interest thereon from date at the rate of **six and one-half**

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being **just outside the City of Greenville, in Greenville County, State of South Carolina, being known and designated as Lot No. 19, Section D of the property known as Washington Heights, plat prepared by N. O. McDowell, Jr. and Julian P. Moore, Engineers, December, 1944, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book M at page 107 to which plat reference is hereby made.**
