with interest from date at the rate of six (6%) per centum per annum until paid; interest to be computed and paid annually and if unpaid when due to bear interest at same rate as principal until paid, and I have further promised and agreed to pay ten per cent of the whole amount due for attorney's fee, if said note be collected by attorney or through legal proceedings of any kind, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I, the said John K. Temple, Jr.

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to it in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said W. N. Leslie, Inc., its successors and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 3 of a subdivision known as Welcome Acres as shown on a plat thereof prepared by Piedmont Engineering Service, dated July 1963, and recorded in the R. M. C. Office for Greenville County in Plat Book DDD, at Page 44 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Welcome Road, the joint front corner of Lots Nos. 3 and 2 and running thence along the line of these lots, N. 39-02 E. 165.5 feet to an iron pin in the rear line of Lot No. 8; running thence along the rear line of Lot No. 8, S. 52-52 E. 76.8 feet to an iron pin at the joint rear corner of Lots Nos. 7 and 8; running thence S. 52-23 E. 12.9 feet to an iron pin at the joint rear corner of Lots Nos. 3 and 4; running thence S. 39-00 W. 170.5 feet to an iron pin on the northern side of Welcome Road; thence along the northern side of Welcome Road, N. 49-41 W. 90.0 feet to an iron pin, point of beginning.

The within mortgage is junior in lien to a mortgage simultaneously being executed by the within mortgagor to First Federal Savings and Loan Association of Greenville in the original sum of \$10,000.00 being recorded simultaneously herewith.

And I do hereby bind myself, my Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the said mortgagee, its successors and Assigns, from and against me, my Heirs, Executors, Administrators and Assigns, and every person whomsoever lawfully claiming, or to claim the same or any part thereof.
