To All Whom These Presents May Concern:

We, J. O. Jones, A. O. Jones and L. E. Rish, of Greenville County

END GREETINGS:

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of <u>Eleven Thousand and no/100</u> (\$11 (100_00_))

Dollars (or for luture advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note for notes se-

cured hereby), said note to be repaid with interest at the rate specified therein in installments of

extended, will be due and payable 18 years after date. The note further provides that it at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder, become immediately due and payable, and the holder may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per contum attoriory's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That I/we, the said mortgagor (s) in consideration of the said debt and sum of moncy aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor (s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, but and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, being known and designated as Lot No. 14 of a subdivision known as Dellvista Heights, as shown on plat thereof prepared by C. O. Riddle, R. L. S. dated June 1963, and recorded in the R. M. C. Office for Greenville County in Plat Book RR, at Page 125 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Greenvista Lane, joint front corner Lots Nos. 13 and 14 and running thence along the eastern side of Greenvista Lane, S. 20-58 E. 125 feet to an iron pin; thence following the curvature of Greenvista Lane as it intersects with Melanie Lane, the chord of which is S. 65-58 E. 35.4 feet, to an iron pin on the northern side of Melanie Lane; thence along the northern side of Melanie Lane, N. 69-02 E. 95 feet to an iron pin at the corner of Lot No. 15; thence along the line of that lot, N. 20-58 W. 150 feet to an iron pin at the joint rear corner Lots Nos. 12 and 13; thence along the line of Lot No. 13, S. 69-02 W. 120 feet to the beginning corner; being a portion of the property conveyed to us by Horace N. Cox, et al. by deed dated June 15, 1963 and recorded in the R. M. C. Office for Greenville County in Deed Volume 725, at Page 249.
