SEND GREETING:

Whereas, we, the said Boyce Sloan and Zelvia W. Sloan
in and by our certain promissary note in writing, of even date with these
Presents, are well and truly indebted to J.C. Roper, d.b.a., Southern Motor
Finance Company in the full and just sum of Eight Hundred Eighty-Five and No/100
- - dollars, to be paid in full on December 12, 1963,

with interest thereon from maturity
at the rate of 7 per centum per annum, to be computed and paid six months in advance
until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid,
the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who
may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the
hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof
necessary for the protection of his interests to place and the holder should place the said note or this mortgage
in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises
to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees; this to be added to

gained, sold and released, and by these Presents do grant, bargain, sell and release unto the said
J. C. Roper, d. b. a., Southern Motor Finance Company, his heirs and
assigns, forever:

"All that certain piece, parcel, or lot of land situate, lying and
being in the State of South Carolina, County of Greenville, being known
and designated as Lot No. 29 of a subdivision known as "View Point
Place" as shown on a plat thereof being recorded in the R.M.C. Office
for Greenville County in Plat Book CC at Page 152, and having, accord-
ing to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern side of Bayne Drive
joint front corner of Lots Nos. 28 and 29, and running thence with the
joint line of said lots, N. 55-25 W. 155.9 feet to an iron pin in the
line of Lot No. 30; thence with the line of Lot No. 30, S. 39-32 W.
69-7 feet to an iron pin on the northeastern side of Bayne Drive;
