All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate lying and being near the City of Greenville, in Greenville County, State of South Carolina, being known and designated as Lot No. 5 as shown on a plat prepared by J. C. Hill dated September 7, 1962, entitled "Property of J. Frank Williams" recorded in the R.M.C.
