DOLLARS (\$ 3500.00), with interest thereon from date at the rate of six and one-half per centum per annum, said principal and interest to be repaid in monthly instalments of FIFTY AND NOTIOOTHS

until the principal and interest are fully paid; each payment to be applied first to payment of interest and then to payment of principal, and

of Piney Road shown as Lot 3 on plat of property entitled Property of Central Realty Corporation recorded in the RMC Office for Greenville County in Plat Book B at Page 86 and having according to said plat the following metes and bounds, to-wit:
