WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and forther sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns.

"All that certain piece, parcel or lot of and, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South prolima, County of Greenville. in Chick Springs

Township, situate on the watern side of Dexter Drive, being shown and designated as Lot 69 on plat of Drexel Terrace recorded in Plat Book QQ at Page 177 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Dexter Drive at the joint front corner of Lots 69 and 70 and running thence with the line of Lot 70 N. 82-07 W. 167.5 feet to pin; thence S. 6-25 W. 100 feet to pin at rear corner of Lot 68; thence with line of Lot 68 S. 82-07 E. 165 feet to pin on Dexter Drive; thence with the western side of Dexter Drive N. 7-53 E. 100 feet to the point of beginning.

This being the same property conveyed to the mortgagors by deed of Lee O. Sullivan to be recorded herewith.

The Mortragors agree that after the expiration of ten years from the date hereof, the Mortgagee may at its option apply for mortgage insurance for an additional period of five years with the mortgage insurance company insuring this loan, and the Mortgagors agree to pay to the Mortgagee as premium for such insurance one-half of one per cent of the principal balance then existing.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected the fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
