WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Seven Thousand Three Hundred and No/100ths-----**

per centum per annum, said principal and interest to be paid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the afresaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor, in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 77 as shown on a plat prepared by C.C. Jones, C.E., dated December, 1962, entitled "Extension of Sharon Park", recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book CCC at page 71, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Eastern side of Melody Drive at the joint front corner of Lots Nos. 76 and 77, and running thence with the line of Lot No. 76 S. 85-30 E. 165 feet to an iron pin; thence N. 4-30 E. 80 feet to an iron pin at the joint rear corner of Lots Nos. 77 and 78; thence with the line of Lot No. 78 N. 85-30 W. 165 feet to an iron pin on the Eastern side of Melody Drive; thence with the Eastern side of Melody Drive S. 4-30 W. 80 feet to the point of beginning.
